1. Introduction to Kernel for Publisher

Welcome to the user manual for Kernel for Publisher, the most effective and convenient .pub file repair tool available that repairs corrupt or damaged MS Office Publisher documents. This user manual comprises step by step guidelines on using Kernel for Publisher.

1.1 Using this Manual

This user manual is intended to guide users on using Kernel for Publisher. We suggest that first time users should read this user manual completely and carefully before proceeding to use the software. However, if you are an experienced user, you can use the table of contents to find out information pertaining to the tasks that you need to perform by using Kernel for Publisher.

1.2 About Kernel for Publisher

Kernel for Publisher is file repair and data recovery software for MS Office Publisher. This software repairs MS Office Publisher document files that become inaccessible due to unexpected system shutdown, power failure, virus attacks, media errors, software crash etc.

You might be familiar with the following error messages if you have encountered MS Office Publisher .pub file corruption before:

- “Publisher unable to open file”
- “Cannot update object”
- General Input/output error
- File link error message on opening Publisher

Kernel for Publisher quickly and effectively resolves the above mentioned errors by repairing corrupt .pub file, keeping the complete document format intact. It restores images, drawing objects, word art, text, and all other components of the corrupt Publisher document.

1.3 Salient Features

Salient features of Kernel for Publisher include:

- Powerful design recovery tool for corrupt Publisher file which recovers graphics, data, word art, and art images
- Support for all versions of MS Office Publisher – Publisher 2000, 2002, 2003
- User friendly graphical user interface, no technical skills required
- Saves file in RTF (Rich Text format) and PUB format
- Free demo to test the capabilities of the tool before purchasing it

1.4 Who Should Use this Software?

The capability of Kernel for Publisher to repair corrupt .pub files makes it appropriate for use by every professional who works on the designing tool – MS Publisher. The software proves beneficial to the publishing industry, designing experts, and small business owners as well.

The software easily repairs the damaged/corrupt marketing material, websites, calendars, greeting cards, postcards, business cards, brochures, and much more. This corruption could have been caused due to virus attacks, improper system shutdown, installation of unsupported software, software crash etc.

2. Getting Started

Now that you have understood the features and potential of Kernel for Publisher, you are ready to get a hand on experience of the software. To start repairing .pub files, you will first need to download and install this software.

It is strongly recommended that before installing Kernel for Publisher, you should go through the installation pre-requisites for the software to ensure that your computer is appropriately configured to run the software.


2.1 Installation Pre-requisites

The various pre-requisites for installing and running Kernel for Publisher can be broadly classified into two major categories – Hardware requirements and Software requirements.

2.1.1 Hardware Requirements:

The hardware requirements for installing the software are as follows:

- Pentium Class Processor
- Minimum 64MB RAM (128 MB recommended)
- 10MB for Software installation
- Disk Space - Enough space to store the repaired files

 You should have at-least 10 MB of free disk space if you want to repair and save a 10 MB .pub file.

2.1.2 Software Requirements:

The software requirements for installing the software can be further grouped into two categories – Operating System requirements and MS Office version requirements. The requirements are as follows:

2.1.2.1 Operating System Requirements

- Windows 2003
- Windows XP

2.1.2.2 MS Publisher Version Requirements

Supported MS Office Publisher versions:


- Publisher 2003
- Publisher 2002
- Publisher 2000

2.2 Downloading Kernel for Publisher for the First Time

After checking your computer with the prescribed system requirements for Kernel for Publisher, you can download and install the software on your computer. You can buy the full version of the software from any one of our authorized resellers– Element5, Asknet, and 2CO.

If you want to try using Kernel for Publisher before buying it, you can download the evaluation version from the following link:

 You can repair .pub files saved on your system by using the evaluation version of Kernel for Publisher; however, to save the repaired file you need to purchase the full version of the software.

2.3 Install Kernel for Publisher

After downloading the installer file for Kernel for Publisher, you can install the software by running the file. To install Kernel for Publisher:

1. Double-click the Kernel for Publisher installer. Follow the on-screen instructions.

The **Setup Installation Complete** screen will be displayed.

2. Click the **Finish** button to launch the software.

2.4 Start Kernel for Publisher

To start Kernel for Publisher:


Click **Start → All Programs → Kernel for Publisher**

Alternatively, you can launch Kernel for Publisher by double-clicking the shortcut icon available on the Desktop and Quick Launch icon.

2.5 Uninstall Kernel for Publisher

You may need to uninstall Kernel for Publisher. To uninstall Kernel for Publisher:

1. Click **Start → All Programs → Kernel for Publisher → Uninstall Kernel for Publisher**. A warning message will be displayed.
2. Click **'Yes'** to uninstall Kernel for Publisher.

 Before proceeding to uninstall Kernel for Publisher, you must ensure that the software is not running in system background.

You can alternatively uninstall Kernel for Publisher from **Control Panel** by performing the following steps:

1. Click **Start → Control Panel** and then double click the **Add or Remove Programs** icon.
2. Select **Kernel for Publisher** and click **Remove**.

A warning message will be displayed.

3. Click the **Yes** button to uninstall Kernel for Publisher.

3. Software Interface

Now that Kernel for Publisher has been installed on your computer, you can start using the software after getting acquainted with the software interface.

3.1 Menu Bar

The Menu bar of Kernel for Publisher comprises three main menus – File, Tools, and Help.

3.1.1 File Menu

The **File** menu comprises three menu items.

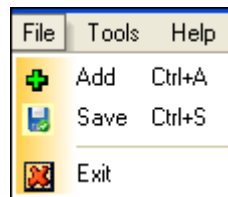


Figure 3.1: File Menu

Menu items in the **File** menu:

Field Name	Field Description
Add	Adds the corrupt publisher file for repairing
Save	Saves the repaired file
Exit	Exists the software

3.1.2 Tools Menu

The **Tools** menu comprises two menu items.

Field Name	Field Description
Setting	Changes the prefix of the repaired file name
Live Update	Helps to get the latest version of the software

The **Help** menu comprises three menu items.

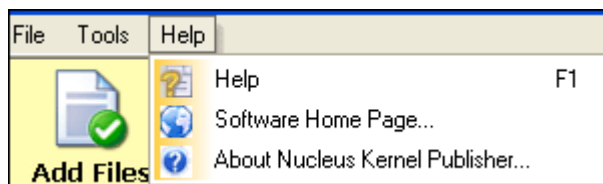



Figure 3.3: Help Menu

Field Name	Field Description
Help	Displays help information for performing various tasks using Kernel for Publisher
Software Homepage	Displays the software homepage on our website
About Kernel for Publisher	Displays the software version and support related information

3.2 Tool Bar

The **Tool** bar in Kernel for Publisher is displayed below the **Menu** bar. The Tool bar provides a convenient and user-friendly method to perform certain actions that can also be performed by using the Menu bar. Read the information in the table below to find out about the Tool bar buttons:

3.3 Buttons Used

Apart from the standard options available in the Menu bar and the Tool bar, following are the other main buttons used in the software:

	Browses the .pub file that needs to be repaired
	Starts the repairing process
	Takes you back to the previous screen
	Stops the repairing process

4. Repairing .PUB Files

Now that you have familiarized with the user interface of Kernel for Publisher, you are ready to repair .pub files.

To repair .pub files:

1. Launch Kernel for Publisher.

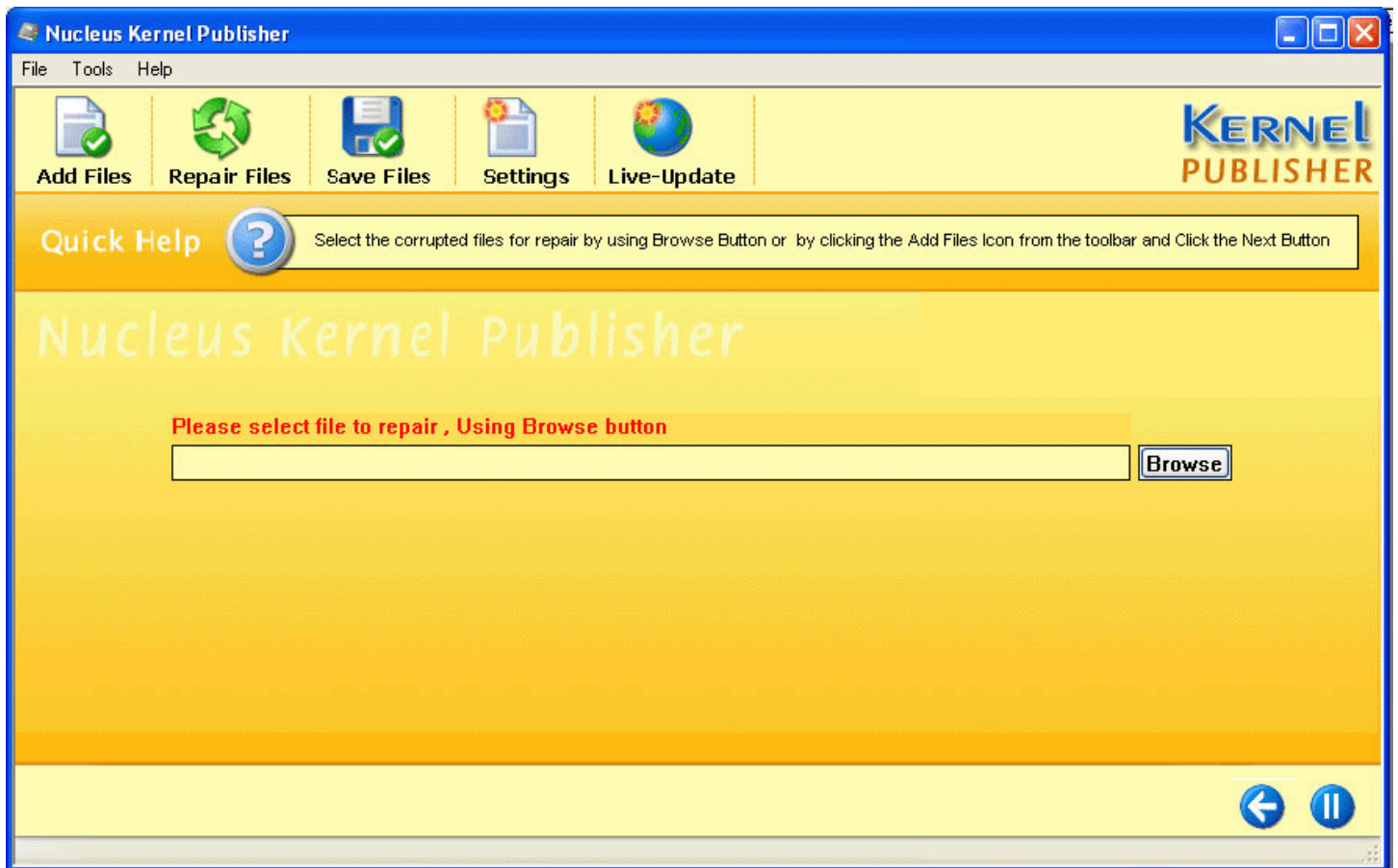


Figure 4.1: Main Window: Kernel for Publisher

2. Click the **Add Files** button to browse and select corrupt .pub files.

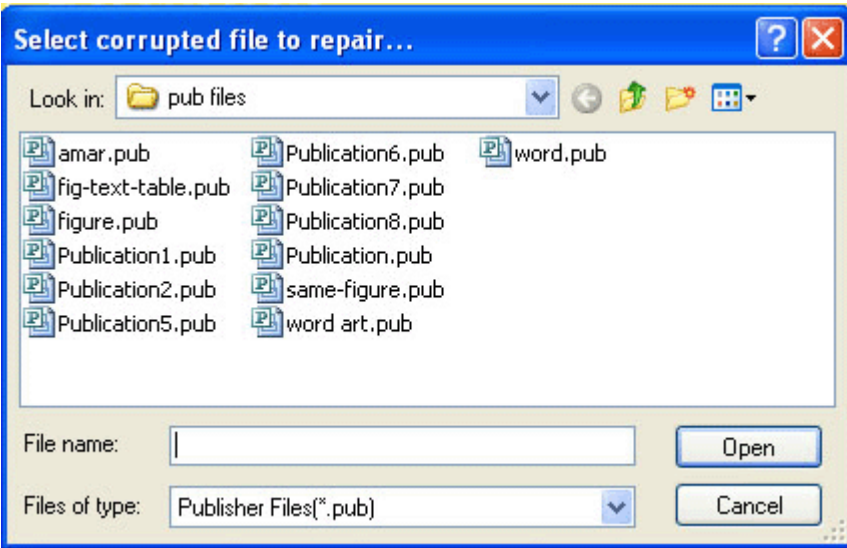


Figure 4.2: Select File to Repair

3. Click the **Next** button to start with the .pub file repairing process. After you click the **Next** button, the software asks you to define the location to save the repaired file.

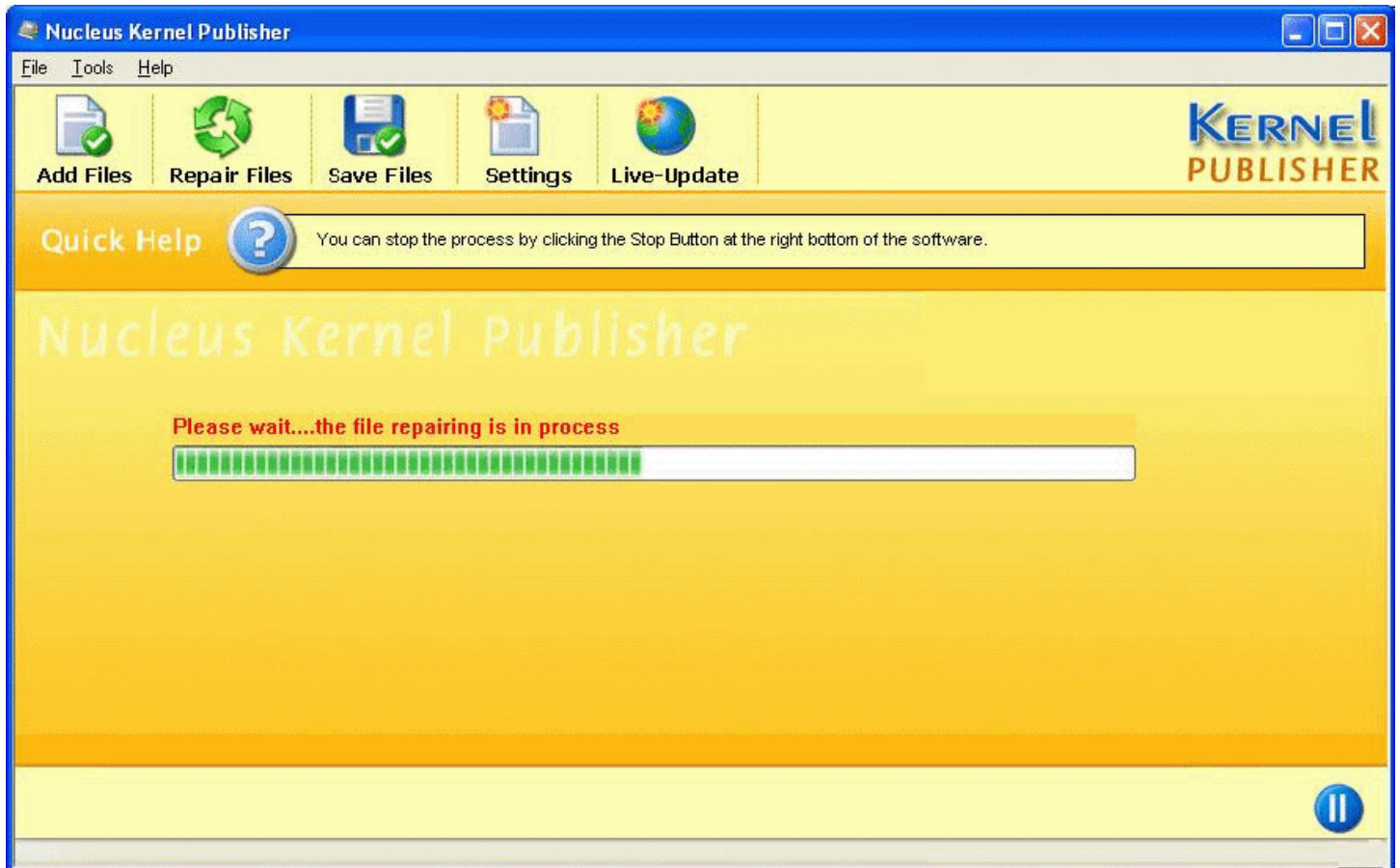


Figure 4.3: Repairing Process Status

4. Browse to your desired location and click the **OK** button.

As soon as the Kernel for Publisher finishes the repairing and saving process, it displays the message '**Files saved successfully**'.

5. Click the **OK** button to exit the software.

5. Full Version

Although you can use Kernel for Publisher evaluation version for free and experience the capabilities of the software, there are certain features that are not available in the evaluation version.

5.1 Requirement of Full Version

By using the evaluation version of Kernel for Publisher, you can repair corrupt .pub files; however, you cannot save the repaired files.

You will need to buy the full version of the software to save the repaired .PUB files.

5.2 Purchasing Full Version

You can buy the full version of Kernel for Publisher from any one of our authorized resellers – Element5, Asknet, and 2CO.

As soon the purchase transaction with our resellers gets completed, our sales team will send you an email comprising the URL to download the full version of Kernel for Publisher and activation details of the software.
